Amendment 1

The Irish Wolfhound Association of the Carolinas (IWAC) was initially organized in 1992 as The Irish Wolfhound Association of the Mid-South by a group of long time Irish Wolfhound owners and breeders.

The objectives of the Club are:

- to encourage and promote quality in the breeding of pure-bred Irish Wolfhounds and to do all possible to bring their natural qualities to perfection;
- to encourage and sponsor education in all areas pertaining to the health and welfare of the Irish Wolfhound;
- to urge members and breeders to accept the standard of the breed as approved by The American Kennel Club as the only standard of excellence by which Irish Wolfhounds shall be judged;
- to do all in its power to protect and advance the interests of the breed and to encourage sportsmanlike competition at dog shows, obedience trials and field trials;
- to conduct sanctioned matches, specialty shows, obedience trials and field trials and any other event for which the club is eligible under the Rules and Regulations of The American Kennel Club.
- to support rescue and placement efforts conducted by the Irish Wolfhound Rescue of the Mid South and other rescue organizations acting in the best interest of the Irish Wolfhound.

In April 2022, we received accreditation by the American Kennel Club (AKC). The major change to our Club was the addition of sanctioned matches, specialty shows, obedience trials and field trials and any other event for which the club is eligible under the Rules and Regulations of The American Kennel Club. This change broadens our activities such that less than 75% of those participating in Club functions will be members of the club.

Our first AKC sanctioned event will be in September 2023. Our Club is currently a 501(c)(7) nonprofit. With additional activities, our club will no longer meet the requirements of a 501(c)(7). We will be submitting a Form 1024-A, Application for Recognition of Exemption Under Section 501(c)(4) of the Internal Revenue Code to the Internal Revenue Service.

Amendment 2

To the fullest extent permitted by the North Carolina Non-Profit Corporation Act as it exists or may hereafter amended, no person who is serving or who has served as member of the Board of Directors shall be personally liable for monetary damages arising out of an action whether by or in the right of the Corporation or otherwise for breach of any duty as a director. No amendment or repeal of this paragraph, nor the adoption of any provision to these Articles of Incorporation inconsistent with paragraph, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
